















On-Resistance vs. Gate-to-Source Voltage



Single Pulse Power



Safe Operating Area, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Foot
