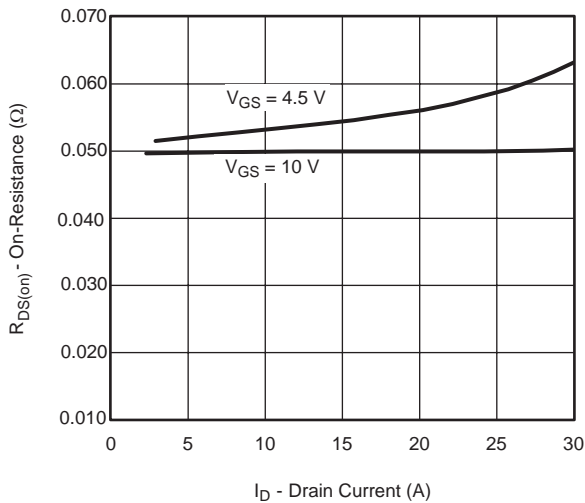

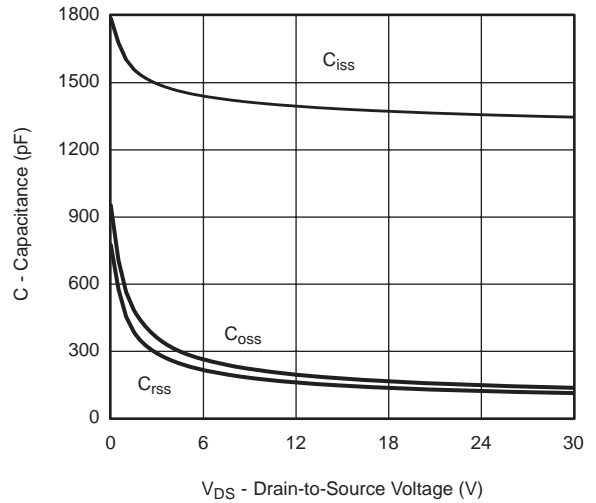

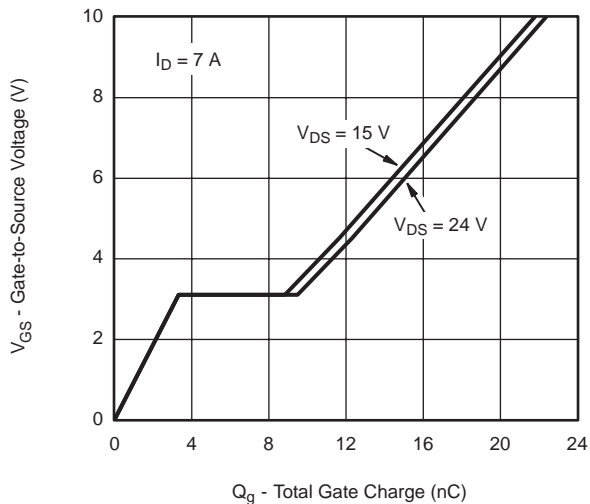
Transfer Characteristics

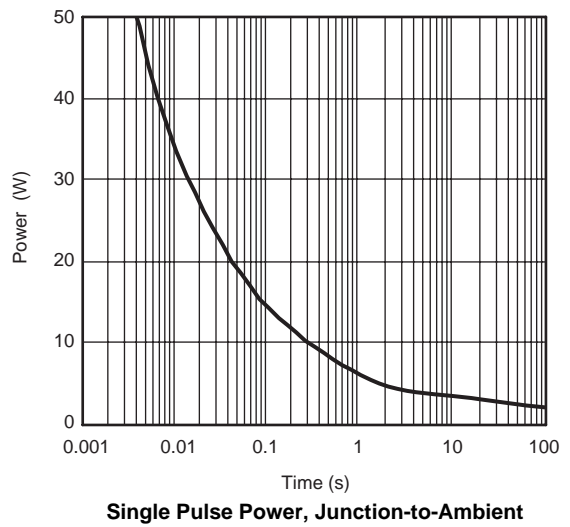
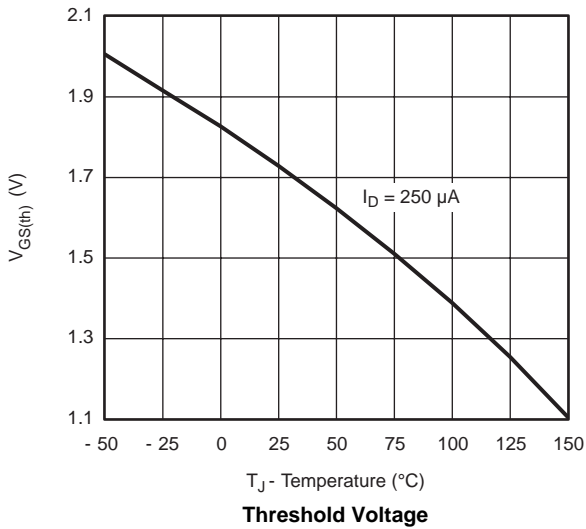
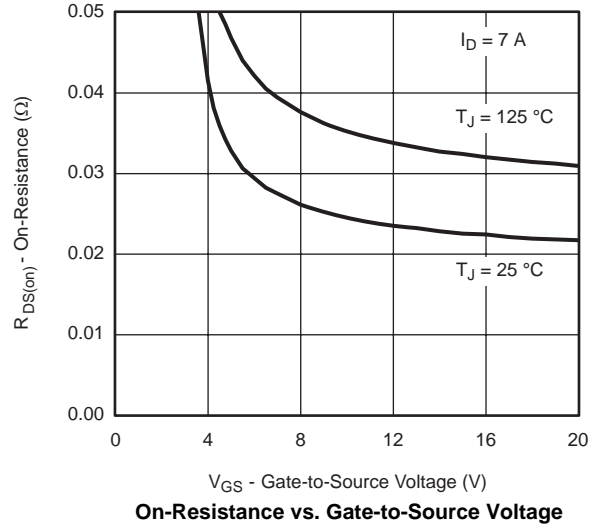
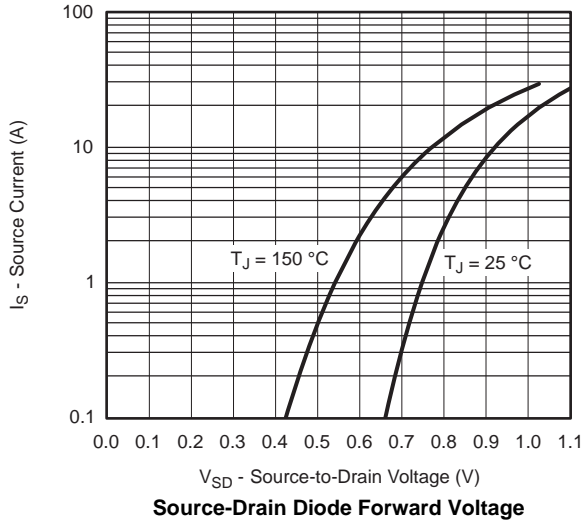


Gate Charge



On-Resistance vs. Junction Temperature

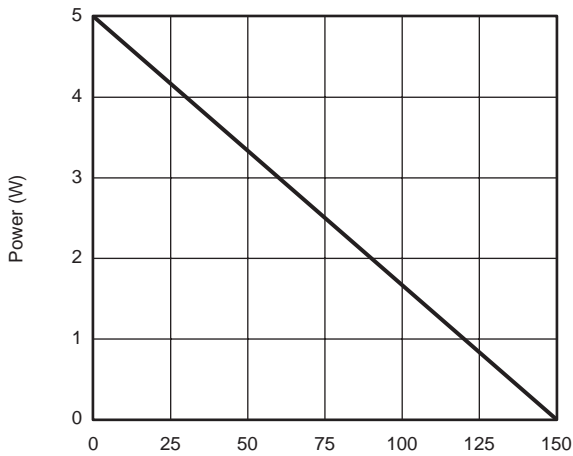

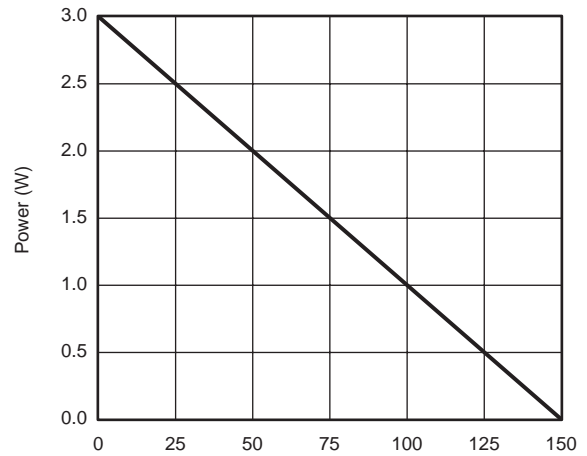

Current Derating*



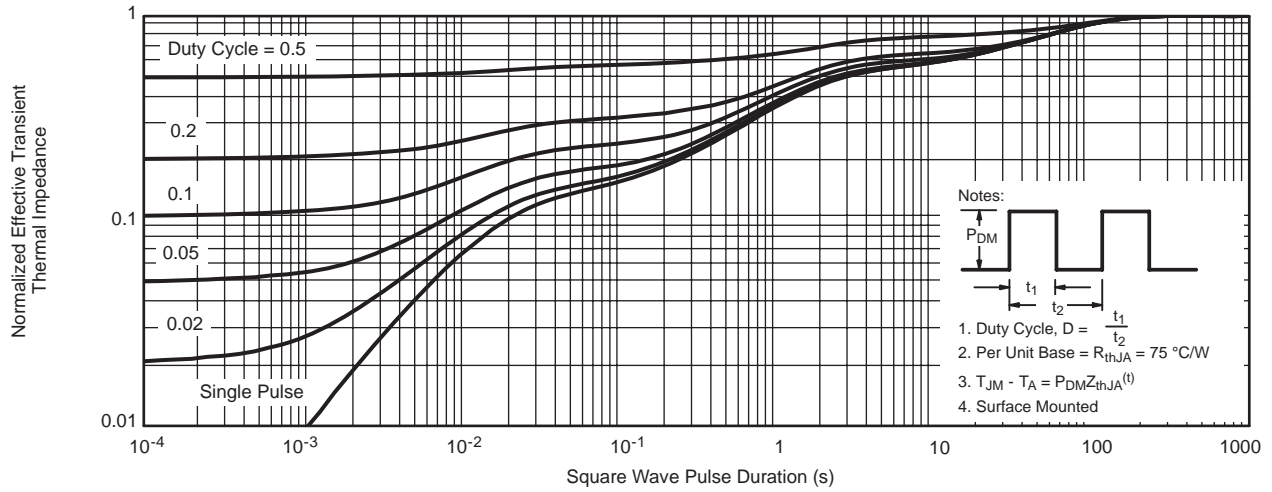
Power, Junction-to-Foot



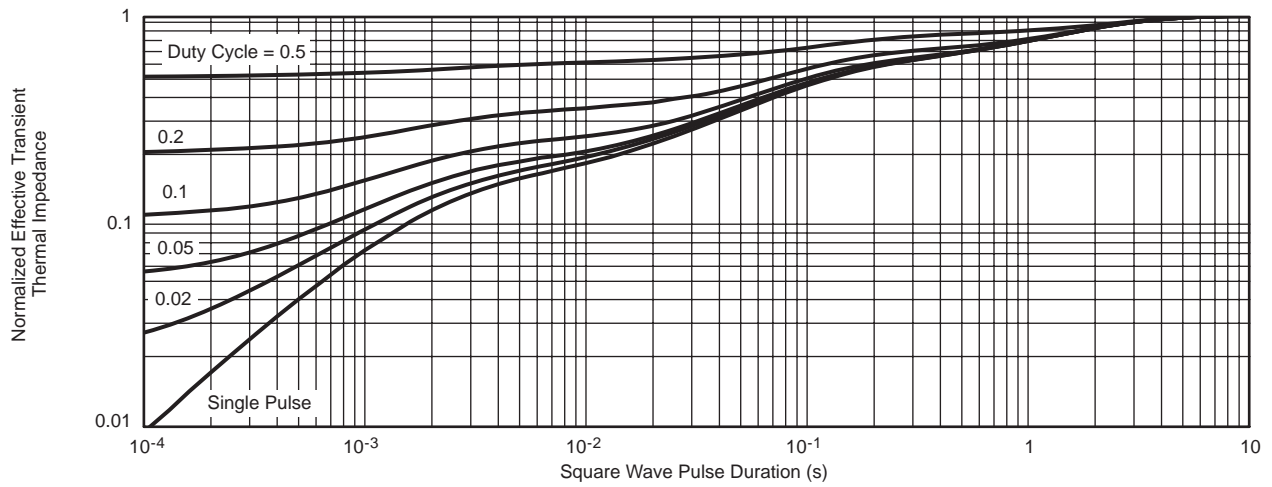
Power Derating, Junction-to-Ambient

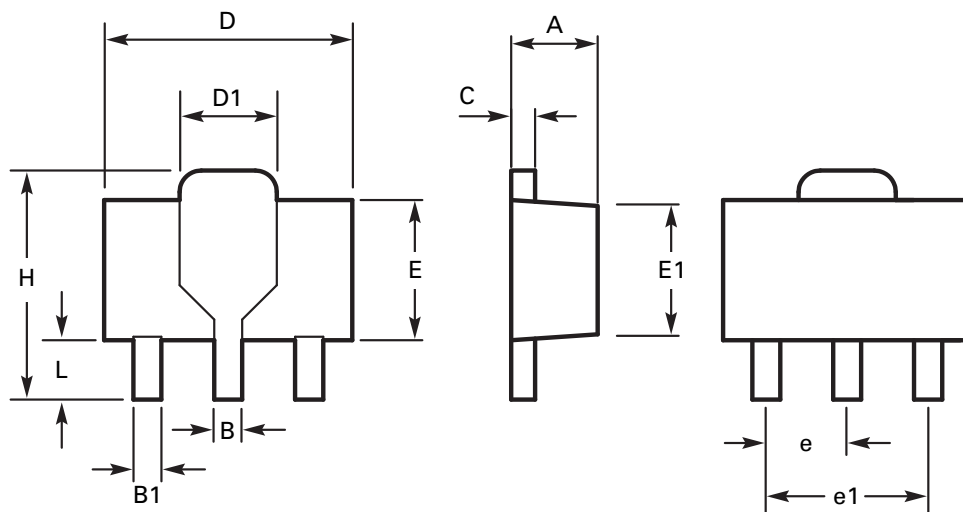


Normalized Thermal Transient Impedance, Junction-to-Ambient
