









Source-Drain Diode Forward Voltage



 V_{GS} - Gate-to-Source Voltage (V) **On-Resistance vs. Gate-to-Source Voltage**










Power Derating, Junction-to-Foot




Normalized Thermal Transient Impedance, Junction-to-Ambient





Normalized Thermal Transient Impedance, Junction-to-Foot


